



The Competition Commission (the Commission) is an independent statutory body established under the Competition Ordinance (Cap. 619) (the Ordinance) which was enacted in June 2012. The objective of the Ordinance is to prohibit conduct that prevents, restricts or distorts competition, and to prohibit mergers that substantially lessen competition in Hong Kong. The scope of the application of the merger rule is limited to carrier licences issued under the Telecommunications Ordinance (Cap. 106).

The Competition Commission is seeking interested applicants to join its professional teams for the following position:

## **Competition Affairs Officer, Investigations II (Operations) (Ref.: CC/CAO(I)INVII20200821)**

The job holder is responsible for conducting investigations into potential anti-competitive conducts in Hong Kong.

### **Responsibilities**

- i) To handle the investigative steps and to conduct factual and legal analysis of alleged contraventions of the Competition Ordinance;
- ii) To assist internal and/or external legal counsels for investigations at the Litigation stage before the Competition Tribunal;
- iii) To represent the Commission in public activities such as advocacy and educational initiatives if requested, and provide general support to the various other functions of the Commission; and
- iv) To perform any other duties as assigned by supervisors.

### **Requirements**

- i) A university degree, preferably in law or economics, or equivalent; and having 4 years' working experience in relevant fields.
- ii) Good command of written and spoken English and Chinese, with strong presentation and writing skills;
- iii) Strong research, analytical ability and solid project management skills;
- iv) Proficiency in using MS Office software including Excel, Word and Power Point;
- v) Attentive to details and good organizing abilities; and
- vi) Candidates with less experience will be considered for a lower job grade and/or salary.

## **Terms of Appointment and Remuneration Package**

Terms	:	Appointment will normally be offered on a 2-year fixed-term contract, renewable depending on performance and operational needs.
Basic Salary	:	Starting from HK\$30,560 per month and depending on experience
Cash Allowance	:	5% of the basic salary
Contract-end Gratuity	:	10% of the basic salary (including 5% employer's contribution of MPF)
Fringe Benefits	:	Annual leave, medical & dental benefits, life insurance and MPF.

Where a large number of candidates meet the specified entry requirements, the recruiting section may devise shortlisting criteria to select the better qualified candidates for further processing. In these circumstances, only shortlisted candidates will be invited to attend the written test and/or interview. Candidates who are selected for interview will normally receive an invitation in about four to six weeks from the closing date.

All applications will be handled in strict confidence. Personal data collected from applicants will only be used for recruitment related purposes and will not be transferred to any third party. Personal data of unsuccessful applicants will be destroyed within 12 months of the recruitment process being completed by the appointment of a candidate for the relevant position.
